1 About Kynetec and Kleffmann

Kynetec is a global market research company, specializing in Animal Health, Agriculture and selected b2b markets. Our main respondent groups are farmers, agronomists and veterinarians. In November 2019, Kleffmann Group merged with Kynetec. Kleffmann is a leading provider of agricultural market research services. In June 2022, in the UK, Kynetec acquired Map of Ag Analytics, a company providing data platforms connecting farms and industry.

Our core business is to collect and process information about availability, usage or performance of specific services, products or industries, to support our clients and business partners. We are committed to very strict ethical standards and business targets. We never share statements from or about individuals. Reporting is generally limited to general information, like behavior, opinions and attitudes of predefined target groups, or market development, market shares, average prices.

We comply with all respective obligations under applicable global data privacy laws such as, but not limited to, GDPR, the UK Data Protection Act 2018 and with all applicable professional rules such as, but not limited to, ICC/ESOMAR International Code of Marketing and Social Research Practice. Kynetec is a member of ESOMAR, an international organization focusing on developing better market research methods. We adhere to the professional standards which ESOMAR sets out for its members and, at the same time, protect your privacy as a participant in our market research activities. Kynetec has been awarded a Fair Data Accreditation from the Market Research Society in the UK which demonstrates our visible commitment to the handling of personal data and our adherence to the 12 Fair Data Principles. This privacy notice sets out the basis on which any personal data we collect from you as a Client (including prospective Clients), Supplier, Research Participant or Job Applicant, or that you provide to us, will be processed. When we contact you, calls may be recorded for quality and monitoring purposes. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

2 Personal Data we collect

We may collect information that can specifically identify you, such as your name, address, telephone number, email address, profession, an audio/video recording etc. when you voluntarily submit it to us. It does not include data where the identity has been removed (anonymous data). The type of personal data we use has been grouped together as follows:

- **Identity** includes name, marital status, date of birth, nationality, profession, gender, age, an audio/video recording
- Contact includes physical address, email address and telephone numbers
- Financial includes bank account details
- **Transactional** includes details about payments between Kynetec and their suppliers and clients
- Usage includes information about how our website, products and services are used
- Marketing information includes preferences on receiving marketing from us (for example our e-newsletters)
- **Technical** we use cookies to collect certain information about individuals who visit our website. Please see our cookie policy for further details
- Research includes survey data or other data collected from participation in research studies
- **Demographic and work authorisation information –** right to work information including immigration and visa status, and other personal data necessary for us to make reasonable adjustments as part of the job application process.
- Background check information (where permitted by law) credit reports, educational and professional history, criminal background checks

Position and competency information – current job title/position, academic/professional qualifications, education, CV/résumé (which might include details of any memberships or interests constituting sensitive personal data), residence history, outside business activities, transcripts and employment references,



details of your nominated referees (including their name, contact details, employer and job role), details of any previous applications made to employment history with Kynetec or its group companies and any other information voluntarily provided by you as part of your job application, such as through interviews. We have no intention of collecting or processing personal data from children or young people. If we become aware that personal data from a child under the age of 16 has been inadvertently collected without parental or guardian's consent, we will use all reasonable efforts to delete such information unless the original data collection exercise requires such information.

For Job Applicants, and only if local employment laws allow this, we may request sensitive personal data relating to you for specific, limited purposes, such as equal opportunities monitoring and to comply with anti-discrimination laws. **Unless we specifically request it, we ask that you do not send us sensitive personal data.**

3 Use of personal data

Processing data is our core function to deliver market research studies to our clients. We have set out below, in separate tables for Suppliers, Clients, Research Participants and Job Applicants, a description of all the ways we plan to use your personal data, and which of the legitimate interests we rely on to do so. We will only use personal data for the purposes for which we collected it as set forth in this privacy notice, unless you have specifically provided your consent to another use of your personal data. If we need to use your personal data for an unrelated purpose, we will notify you and explain the legal basis which allows us to do so.

Please note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. Please contact us if you need details about the specific legal ground we are relying on to process your personal data where more than one ground has been set out in the table below.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

4 How we share personal data

We will disclose your personal data only as described below. We will take appropriate measures to ensure that your personal data is processed, kept secure and transferred or accessed according to applicable global laws.

1. Legal entities within the Kynetec and Kleffmann group of companies

We are a global organization. Personal data may be transferred or accessed via a secure portal by one or more affiliated companies. We guarantee that the processing of such data will take place exclusively in the UK, a Member State of the EU, another country of the European Economic Area or in a third country that has been determined by the European Commission or UK government as ensuring an adequate level of data protection (see here for a list of countries determined as adequate by the UK government and here for a list of countries determined as adequate by the UK government and here for a list of countries determined as adequate by the European Commission) or to another country where we have put in place appropriate safeguards for the transfer, such as standard contractual clauses. Kynetec and Kleffmann group companies outside of the EU have entered into an intra-company data protection agreement using the standard contractual clauses adopted by the European Commission to safeguard your privacy and legitimize international data transfers. A list of countries outside of the EU from where group companies may access your information is contained in Appendix A.

2. Business transfers

In connection with any business reorganization, restructuring, merger or sale, or other transfer



of assets, we will transfer data (including personal data) as necessary, provided that the receiving party agrees to respect your personal data in a manner that is consistent with applicable data protection laws. We will continue to ensure the confidentiality of any personal data and give notice should any personal data become subject to a different privacy notice.

3. Public bodies

We will only share your personal data with public bodies where we have a duty to disclose this as required by law; for example, requests from courts, regulatory agencies, law enforcement agencies and other public and government authorities, which may include authorities outside your country of residence.

4. Agents, Contractors, Third Party service providers and providers of professional services We will only share your personal data with our agents, contractors and third parties where we have a legitimate business need to disclose this in order that they may perform their duties. We share your personal data with our service providers who act as processors, notably the service providers through which we send out our farmer newsletter, our payroll/incentives partners, IT service providers such as cloud service providers and recruitment platform providers or our agents/agencies who proceed with the interviews. They will only process your data on our instructions and they are subject to a duty of confidentiality. All service providers, are required to sign a Data Processing Agreement with us prior to commencing any work for us. We also share personal data with other providers of professional services, such as third parties who assist with legal, financial/audit, management consultancy, insurance, health and safety and security related issues as well as for job applicants only, recruiters and background check or other screening providers.

5 Sources of Personal Data

We collect personal data directly from you and from other sources where permissible and in accordance with applicable law.

For Clients, Suppliers and Research Participants, we collect personal data from you and the following third party sources:

- Our Clients;
- Publicly available databases;
- Third party data providers;
- Joint marketing partners;
- Third-party organizations, when they share personal data with us to, for example, facilitate mergers, acquisitions and other reorganisation and restructurings of our business;
- Public and/or government and/or regulatory authorities, including courts, tribunals, regulators and government authorities;
- Third persons involved in a legal action; and
- Providers of professional services (e.g., lawyers, auditors, insurers).

In relation to Job Applicants, we collect personal data from you and the following third party sources:

- References provided by referees;
- Academic transcripts and certificates provided or confirmed by academic institutions or certification providers;
- Background checking agencies and other external databases (e.g., credit reference agencies) where permitted by law;
- Recruitment and executive search agencies; and
- Information collected from publicly available sources, such as professional social media accounts such as LinkedIn.

6 Security

The security of your personal data is very important to us. We have put in place appropriate physical, electronic and administrative security measures to safeguard the information we collect.



In the event of a suspected data breach containing personal data, we will follow all applicable data breach notification laws.

7 Your legal rights

As a data subject you have specific legal rights relating to the personal data we collect from you. We will respect your individual rights and will deal with your concerns appropriately.

Data subjects have the right to:

- **Request access** to your personal data (commonly known as a "data subject access request"). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it.
- **Request correction** of the personal data that we hold about you.
- **Request erasure** of your personal data. If we are unable to comply with your request of erasure for specific legal reasons, we will notify you of these reasons (if applicable) at the time of your request.
- **Request portability** of your personal data to a third party in a commonly used, machine-readable format.
- **Object to processing** of your personal data
- **Request restriction of processing** of your personal data
- Withdraw consent at any time. Please note this will not affect the lawfulness of any processing carried out before you withdraw your consent.
- Lodge a complaint with the relevant country Supervisory Authority (for example, the Information Commissioner's Office (ICO) is the UK's supervisory authority for data protection issues).

We will try to fulfill your request within the time period required by law. Occasionally it may take us longer depending on the scope of your request. In this case we will notify you and keep you updated. We will not charge a fee for dealing with your request unless it is deemed to be excessive or repetitive.

If we are unable to give you access to all or some of your personal data due to lawful exemptions, we will advise you of the reason for this.

In some cases, we may not be able to look up your personal data due to the information identifiers you provide in your request. Examples of personal data which we cannot look up are:

- data collected through browser-cookies
- data collected from public social media sites provided you have posted your comment under a username which is not known to us.

In these cases, unless you provide additional identification information, we will be unable to comply with your request.

8 Retention of your personal data

In general, we will delete the personal data we collected from you if they are no longer necessary to achieve the purposes for which they were originally collected. However, we may be required to store your personal data for a longer period due to statutory provisions or when it is advisable to retain personal data to defend or bring potential legal claims.

In addition, we will not delete all of your personal data if you requested us to refrain from re-contacting you in the future. For this purpose, we keep records containing information on people who do not want to be re-contacted in the future.

For Job Applicants, the period for which we will retain your personal data will also depend on whether we have an ongoing relationship with you (including whether you are accepted for a role at Kynetec).



9 Changes to this Privacy Notice

We reserve the right, at our discretion, to modify our privacy practices and update and/or make changes to this privacy notice at any time. For this reason, we encourage you to review this privacy notice on an ongoing basis. We will treat personal data in a manner consistent with the privacy notice under which they were collected, unless we have your consent to treat it differently.
